Scouts South Africa (SSA) require a non-negotiable **annual Capitation fee of R500** per uniformed member of our Cub & Scout Group.

In order to register your Cub or Scout for 2023, R500 per child is to please be paid at the latest by 25<sup>th</sup> January 2023. Balance of fees payable, using either option below:

**OPTION 1:** *Early Bird fee* (Single payment) due by 25/01/2023.

OR

**OPTION 2:** Capitation fee due by 25/01/2023 + eight instalments due by 31/8/2023

**PRO-RATA FEES: R175 (R135 for siblings)** is payable **monthly** in advance, up to the end of October 2023 for any Cub/Scout joining the Group (being invested) during the year.
